- *By using this ticket, the holder hereof agrees to and accepts all conditions of acceptance contained herein and all arena/organisation rules and standards of conduct posted in or about the venue.*
- *Ensure your ticket is purchased from the Jersey Reds website only. Those with counterfeit tickets will be refused admission and maybe prosecuted.*
- *Tickets may not be resold for more than face value*
- *It is with regret that we cannot Transfer, exchange or refund any tickets after purchase.*
- *Event partners reserve the right to refuse admittance to the venue or to remove any person from the venue for reasons of public safety, any unacceptable behaviour likely to cause damage, nuisance or injury or for any breach of event partners terms & conditions.*
